School Voluntary Contribution 2003 (Section 99)

Under the Education Act, 1999 there are a number of changes to the manner in which contributions and charges are requested from parents. One of the major changes is the requirement for schools to give parents details of the maximum costs that the education of the children will incur in the coming school year.

The costs can be broken into four sections:

- 1 Annual School Voluntary Contribution
- 2 Optional costs associated with an Educational Program
- 3 Personal use items
- 4 Optional costs for Non Educational Activities
